FY19 State Budget Includes DSA

\$1.1 Million Approved

We're pleased to announce that \$1.1 million was included in the final FY19 State Budget. The Advisory Board thanks the House for including \$1.1 million in their version of the budget, as well as the Senate for accepting the House recommendation in the conference report, and



Governor Baker for not vetoing the \$1.1 million line item (as he had included \$500,000 in H2). The Advisory Board looks forward to working with all branches of state government to keep water and wastewater funding on the state's agenda moving forward.
